Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges

- The Government of Nepal (GoN)** has allocated TB-SWAp funds to Dhawalagiri Rural Municipality Muna Myagdi for **Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Short span Trail Bridges (SSTB). Bid is open to all eligible Nepalese Bidders.
- The Dhawalagiri Rural Municipality Muna Myadi invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

- Bidding documents may be purchased from the office of Dhawalagiri Rural Municipality, Muna Myagdi, or **www.bolpatra.gov.np** by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) 30th Days [(2075/11/27 (11th March 2019))] from the first date of publication of this notice. For the purpose of Fabricators who choose to submit their bid electronically through **PPMO's website: <http://www.bolpatra.gov.np>** the bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Fabricators. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document in the Dhawalagiri Rural Municipality, Muna Myagdi's Rajaswa (revenue) account either by direct deposit or by tele-transfer of deposit in the DRM account for the purchase of the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

- Bids must be submitted to the office of Dhawalagiri Rural Municipality, Muna Myagdi or through www.bolpatra.gov.np, on or before **12.00 hrs. noon on. 31th days.** [(2075/11/28 (12th March 2019))] Documents received after this deadline shall not be accepted.
- Bids will be opened in the presence of Bidders' representatives who choose to attend at **13.00 hrs on 31th days from the first date of publication of this notice** at the office of Dhawalagiri Rural Municipality, Muna Myagdi, Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a **minimum of 2.5 % of the Estimated amount** as shown in the table below, which shall be **valid for 30 days** beyond the bid validity period.
